

## CALL FOR YOUNG ARTISTS

### 2025 Lynnwood Recreation Center Art Gallery Exhibitions

### Deadline: October 27, 2024

We invite youth visual artists (under 18) who live in Washington State to apply. Exhibits are held at our very popular Rec Center. Artists are juried by the Lynnwood Arts Commission and will be announced by December.

**APPLICATION:** By applying to be in this exhibit, you agree to the terms and conditions stated in this form.

Email the following (or mail equivalent):

2. Attach up to 8 JPEG files of artwork. Also 1 photo of yourself. At least 1200x1500 pixels at 300dpi for use in publicity.
3. Email is preferred. If unable to email, mail the application including the completed information form with CD containing up to 8 JPEG images (min 1200x1500 pixels). Please note that CD will not be returned to you.

**LENGTH OF EXHIBITS:** Approximately 2 months, during a specified period in 2025. All artwork displayed must remain installed for the specified duration of the exhibit.

**SIZE RESTRICTIONS:** 2-D work from 12"x12" to 30"x30" properly wired for hanging.

**GALLERY:** Located inside Lynnwood Rec Center at 18900 44<sup>th</sup> Ave W, Lynnwood, WA 98036. The total space is 12 linear feet accommodating 6-8 pieces of medium sized art. We encourage artists to visit and preview the space. Hours: Monday - Friday 5:30am - 9:30pm, Saturday 7:00am - 9:00pm, Sunday 9:30am - 6:30pm

**SUBJECT MATTER:** This is a public space visited by people of many cultures, nationalities, and ages. We reserve the right to not exhibit work that we deem unsuitable for the public space (for example, works that contain nudity, or inappropriate language).

**DELIVERY & PICK-UP:** Artwork must be hand-delivered and picked-up on the day(s) scheduled. There is no storage for packing materials. Art delivery is usually on weekdays. Installation (you do not need to be present) on same day.

**ART SALES:** Contact information of interested buyers will be provided directly to artists to complete purchase transactions. No sales commission is charged.

*We reserve the right to invite artists who do not apply and to NOT select an artist through this application process.*

**LIABILITY:** Please be advised that every reasonable precaution will be taken during the receiving, installation, exhibition and return of your artwork but the City of Lynnwood, their officials, officers, employees or volunteers do not assume responsibility for loss or damage that might be incurred during this process. All work needs to be of substantial enough nature to withstand these procedures. We encourage each artist to carry their own insurance.
